NEW 2021 Summer COVID-19 Guidelines

Effective June 2, all fully vaccinated Wisconsin 4-H staff, volunteers and participants are no longer required to wear masks during programs. We ask that individuals who are not fully vaccinated, including youth under 12, continue to wear masks. Staff and volunteers will not enforce mask wearing or ask for proof of vaccination for those not wearing masks. Masks may still be worn if preferred and individual masking choices should not be interpreted as an indicator of vaccination status.

- Outdoors: Physical distancing is no longer required outdoors for vaccinated people. Individuals who are not vaccinated should maintain 6 feet of physical distancing and, if physical distancing is not possible, wear a face covering.
- Indoors: There are no group size limits on indoor gatherings as long as a minimum of 6 feet of physical distancing is able to maintained, regardless of vaccination status.
- Transportation: Any individual who is not vaccinated should wear a face covering when driving or riding with others. Vehicle occupancy is recommended to be no more than 50 percent of capacity when traveling with an unvaccinated individual(s).

This updated policy applies to all Wisconsin 4-H programs including overnight programs, 4-H programs at county fairs and food stands.

As a reminder, Wisconsin 4-H staff, volunteers and participants **should continue to follow local public health guidance**. For the most updated list on COVID meeting rules please go to https://4h.extension.wisc.edu/4-h-fags-related-to-covid-19/

The following policies are currently in place, but may change depending on the number of COVID-19 infections in Wisconsin, guidance from the CDC and DHS, and UW-Madison policies.

POULTRY

<u>Blood Testing</u> - July 17th, from 8:00 a.m. until 11:00 a.m. on the Fairgrounds by the Poultry Barn. Reminder that blood testing is required this year.

<u>WORKSHOP</u> - July 28th on the Fairgrounds by the Poultry Barn at 6:30 p.m. Topics covered will be pre-fair and what to expect at the fair. This is a GREAT workshop for new members to attend to know what to expect and know coming to the 2021 Pierce County Fair. Is also recommended for return poultry members too! Poultry Pullorum Testing Again Required for Fairs, Shows

The Department of Agriculture, Trade and Consumer Protection (DATCP) is once again requiring pullorum-typhoid testing for birds exhibited at fairs and shows. In 2019, DATCP issued a waiver for testing requirements because the antigen used to conduct the test was not readily available. The waiver has been rescinded now that the antigen is once again readily available.

Testing for Individual Sales No Longer Required Testing for individual sales, including swaps, is no longer required. This change was issued in the new waiver implemented in February 2021. LIVESTOCK INFO -

BUYER SIGNATURE SHEETS, ADDITIONAL BUYER NAMES, YQCA CERTIFICATES & WYL

EDUCATIONAL FORMS are due **NO LATER than JULY 21ST.** They may be turned in to Jim Geraets, Deanna Hines or the Pierce County Extension Office. YQCA certificates & WYL Educational forms (not buyer sheets) may also be submitted via email to piercecountylivestockcommittee@gmail.com

YQCA: Just a reminder that all Livestock exhibitors MUST take the YQCA training to be able to show at the fair. This includes all beef, goats & sheep exhibitors that are showing breeding stock and not selling an animal on the auction. Classroom trainings have all been completed but the training is still available online at yqca.org. If you still need to complete this please do so ASAP so you have time to get your certificate & get it sent to us by July 21st.

<u>WORKSHOPS</u>: All livestock participants are also required to complete at least one workshop for each species that they are planning to show. If you are still in need of a workshop there is only one in-person workshop remaining but there are several online opportunities you can use to complete this requirement. Don't forget you must also complete the WYL Educational form & get it turned in by July 21st. Forms have been emailed out several times and are available on our website at piercecountylivestock.weebly.com.

<u>AUCTION ETIQUETTE & FAIR INFO WORKSHOP:</u> July 21st @ 7pm in the Drewiske Building. This will be the last workshop for the year! <u>Buyer signature sheets</u>, <u>YQCA certificates & Educational forms can be handed in at this workshop</u>. Animal ID forms & Drug sheets will also be available for anyone that would like to pick them up.

SWINE VET CHECKS: Swine vet checks can be done any time between now & the fair. Upon completion of your vet check you will receive an intrastate movement sheet - "the pink sheet." This sheet is to be turned in upon arriving at the fair BEFORE your animals can be unloaded.

ANIMAL ID FORMS: These sheets must be handed in to each superintendent before unloading. All animals must be recorded on an Animal ID form. However, it does not mean that every exhibitor needs their own sheet. There should be a sheet for each species (project area), for each truck load. For example, if one person hauls in 6 dairy cattle for 3 exhibitors, they need one sheet. If a person hauls in one beef and 3 dairy animals, they need 2 sheets - one for the dairy superintendent and one for the beef superintendent. These sheets will be emailed out & are also included in the fairbook. If you have any questions please email us.

MARKET ANIMAL DRUG SHEETS: Every market animal brought to the fair must have a drug sheet listing any drugs or meds it was given so we can check to make sure they are safe for consumption. These sheets will be emailed to exhibitors along with the link to sign up for auction jobs on July 22nd & will be collected upon your arrival at the fair.

DREWISKE BUILDING PEN SET UP: Pen set up in the Drewiske barn will be Sunday, August 8th following the archery shoot at approx 5pm. Everyone is welcome to come & help but all goat, sheep & swine exhibitors should be there to help set up the pens. Exhibitors are asked to help clean them up on Sunday after the fair is over as well.

<u>PRE-FAIR WEIGHT CHECK</u>: Exhibitors showing beef, goats & sheep can bring their animals in for pre-fair weight check on Monday, August 9th in the new scale house. Sorry NO PIGS per the movement rule. The scale will be open from 5-7pm.

PLANNING TO SELL AN ANIMAL ON THE AUCTION??? All exhibitors planning to sell at the auction are required to complete an "auction job." We will be signing up for auction jobs online again this year just like we did in 2019. The link for the sign up sheet will be sent out at 5pm on July 22nd to all participants that have their completed paperwork turned in.

<u>MANDATORY PRE-AUCTION MEETING</u>: This will take place **SUNDAY**, **AUGUST 8th** @ **6:30pm**. Anyone attending the state fair email the Livestock Committee for further instruction.

FAIR ENTRY, WEIGH IN & ULTRASOUNDING: Don't forget to check the fair book to make sure you have all your animals entered on time or to make sure you are ready to go if your animals need to be weighed or have an ultrasound! ALSO, PLEASE BE RESPECTFUL TO ENTER & EXIT AS YOU ARE TOLD WITH ANY TRAILERS.

IMPORTANT UPDATES FOR SWINE EXHIBITORS:

- This year we have banned the use of ractopamine hydrochloride (Paylean) & you will all be
 emailed a form to fill out (similar to the drug form) stating that you did not feed your hogs this
 product. If you did not receive this form please let us know. This form MUST be signed & turned in
 upon arriving at the fair along with your pink vet sheet & drug sheet.
- PAYLEAN TESTING: We will be collecting samples from each exhibitor upon your arrival at the fair before the animals are allowed to enter the barn.
- We ask that you please bring your hogs to the fair clean. Washracks will not be available until
 after ultrasounding as they will be used for collecting samples

CARCASS SHOW & AUCTION CHECKS: This will take place on August 18th @ Spring Valley High School starting 7:30pm. Every exhibitor that sells on the auction will be <u>required</u> to bring a written thank you, stamped & addressed for your buyer to turn in before you can get your check.

Horse Project

Summer practices are getting closer to the end and fair is fast approaching! Here is a summary of the many remaining important dates. Updated calendars were emailed to horse project members. Be sure to refer to the latest calendar and not your old one; many dates have changed.

- If you have not yet sent in your Equine Fair Request form (stalling form) that was due July1st, please do so ASAP. If you don't plan on stalling your horse, that's fine but you still need to fill out the form and send it in so we know.
- If you are taking lessons from an offsite instructor, you must have your form(s) in to the committee by July 31st so we know that you have met your requirements for ALL disciplines in which you are participating: gymkhana, pleasure, and jumping.
- Companionship project is due July 31st. Please email your records to the committee email.
- The last practices for pleasure and gymkhana: Thursdays only, July 15, 22, and 29
- August 4 starting at 6:30 pm there will be a mock PLEASURE show where we'll cover showmanship, western/English pleasure and western/English equitation. We'll discuss western riding and trail. If time allows, possible mini in hand. This is like a schooling show and we'll have people on hand to help you understand what's being judged. This show DOES NOT count towards fair requirements and this is NOT mandatory, but is highly recommended.
- Aug 5 starting at 6:30 pm there will be a mock GYMKHANA show where you'll be walk/trot or running the patterns depending on what class you signed up for. Again, This show DOES NOT count towards the fair requirements and this is NOT mandatory, but is highly recommended.
- Drill team practices: Wednesdays, July 14, 21, and 28.
- SRP Trail Practices: Monday 7/12, Tuesday 7/13 at 6:00 pm
- SRP Evaluation: Saturday, July 17. See separate email for detailed schedule.
- Over Fences practices that are left are Tuesday 7/20, Tuesday 7/27, Friday 7/30, and Friday 8/6.
- Flag practice for anyone interested in carrying a flag at the fair will be next Monday, July 19 at 6:00 and Friday, July 23rd at 6:00. Flag education only counts towards education credit if you HAVE NOT attended before.
- Make sure you have got your 3 education credits in! These are very important!! You must also have attended Winter Round Up or watched the recording. Be sure to turn in your Verification sheets with your education on them at any remaining practice or event.
- MARK YOUR CALENDAR... Sunday Aug 8th is barn clean up starting at 3 pm. Even if
 you are not planning on stalling, you are asked to come help. Bring brooms, rakes and
 shovels. We'll also be painting the arena.

You'll be getting your stall this day and if you'd like to clean it this day (water, bleach, etc...) you can. NO DECORATIONS can be put up this day, nor can you bring tack or shavings. MANDATORY FAIR MEETING will follow at 5 pm in the big picnic shelter. You as a participating member MUST attend OR have a parent attend this meeting. Your Numbers will be given out at this meeting and they will NOT be given to anyone else but you or your parent. There will be LOADS of INFORMATION given out at this meeting, so please come to listen and ask questions!

Pierce County 4-H Shooting Sports

Summer Schedules for Archery, Air Pistol, Muzzleloader, Shotgun, Smallbore pistol & Smallbore Rifle have been determined & pending approval from the Pierce County Fairgrounds & the River Falls Sportsmen's Club. Once all the schedules have been approved you will be receiving a detailed email for each discipline you are enrolled in. Just like the Air Rifle practices we held this past spring, you will need to register in advance for each discipline via a Google Form.

Archery & Air Pistol safety: Anyone that is a 1st or 2nd year shooter in either one (or both) of these disciplines will be required to complete Safety training. However, for this year this will not be done at a practice instead it will be offered as an online format that will be completed BEFORE attending any practices. This information will also be included in the detailed email for each discipline.

Anyone planning to shoot for the fair competitions must make the required number of practices for each discipline they plan to shoot. Safety does not count as a required practice. Requirements are as follows:

Archery - 2 practices
Air Pistol - 2 practices
Air Pistol - 2 practices
Shotgun - 1 practice
Smallbore Rifle - 1 practice

All practices for these events will be held in the evenings on their respective nights HOWEVER, the schedule is quite different from years past. If you are an experienced shooter & don't think you will be able to make your required practices but would still like to compete in the fair shoots, you may submit a letter (via the email listed below) asking to be excused from practices. Please Note: letters will be approved by the committee on an individual basis. We WILL reply with the committee's decision. Please do not assume that submitting a letter automatically excuses you. Letters must be submitted to the committee NO LATER than July 7, 2021. Letters received after this date will not be accepted.

Fair shoots - plan ahead! As of now, fair shoots are scheduled that as they have been in the past:

Saturday, August 7th: All Powderburning disciplines & (Classes W-Z) AND Air Rifle Silhouettes (Class V-Silhouettes ONLY) will take place at the River Falls Sportsmen's Club. A more detailed schedule of exact shooting times will come out closer to the event.

Sunday, August 8th: Archery, Air Rifle Bullseye & Air Pistol (Classes R-V) will take place at the Pierce County Fairgrounds.

Due to moving the llamas into the east side of the Silver Barn, space will be tight. Couches and picnic areas are prohibited. Couches will be removed from barn by Groundskeeper if found.

Please Read Carefully

This section is very important to read. Every two years when we change the Fairbook, something is altered that will result is a change from the way things have "always been done in the past". This is not a complete list, so please review the beginning of the Fairbook page 2-5 for check-in times and judging times, the regulations on page 15-29 and then refer to each individual department that you are entered in. Conference judged projects change every two years so check front of book. If you have a question please call the Fair Office 715-273-6874 or the UW Extension Office 715-273-6781 to avoid problems.

For the safety of our exhibitors, exhibitor's animals and the fairgoers, we are encouraging that exhibitors use the earlier entry times for bringing in their animals to the Fair.

CHECK-IN TIMES and Information:

An Animal ID and Check-In Information sheet MUST be given to the Superintendent at unloading for all animals coming to the fair. "A SEPARATE FORM IS NECESSARY FOR EACH SPECIES."

Please complete forms prior to arriving with all appropriate identification information completed. A form is found on pages 125 & 127 of the Fairbook and on fair website.

BRINGING YOUR ANIMALS TO THE FAIR: When bringing your animals onto the grounds, it is vital that everyone follow the same in-out procedures. Dairy, Beef, Swine, Sheep & Goats, should all ENTER through the EAST gate and EXIT out the NORTH gate. Dairy & Beef must enter the cattle arena through the east end, stop in the middle of the show ring area to be vet checked then your animal can be unloaded. You must then exit out the west end of the Arena barn and exit the fairgrounds through the north exit gate. Unloading of animals on the east side doors is not permitted. Swine, Sheep & Goat, please use the unloading area on the north side of the Drewiske Barn as you have done in the past.

Entry Tag Info

JR. Fair & OPEN Class Entry Tags can be picked up between 8:00-4:30 p.m. at the Seyforth Building, Pierce County Fairgrounds starting Monday, Aug. 2nd. (No pick up at Extension Office).

Check to see if your club leader picked them up first. Some of the leaders pick up the entire clubs tags to hand out at a meeting if you have one planned during that time. PICK UP YOUR TAGS EARLY! DON'T WAIT FOR THE LAST MINUTE to avoid problems day of entry. If you notice any issues with your entry tags call the Extension Office at 715-273-6781 as soon as you notice it to have it checked out.

Each exhibit gets an entry tag, which is used to identify the item (animal, vegetable, or mineral) from the other 11,000 items that are entered in the Pierce County Fair annually. Exhibitors need to pick up their entry tags and display them on their exhibit. In the case of animals, they may be put on a cage or pen BUT MUST be shown to the superintendent or ring steward upon request. Start with picking up your entry tags. THIS IS VERY IMPORTANT! IF TAGS ARE NOT PICKED UP, YOU ARE NOT ENTERED AND CANNOT SHOW AT THE FAIR.

Checking in your exhibit - refer to the front of your Fair book (pgs. 2-5) for specific details on checking in your tagged exhibits. Superintendents and helpers are only available at certain times for check-in. Do not be late for these times.

Your Junior Fair season pass will be in your entry tag envelope. Do NOT lose it! It will NOT be replaced.

If you're an Explorer and taking another project you will follow the schedule in the front of the book for that other project that is not Exploring. All Exploring Projects will be judged on Monday between 12 noon and no later than 6 p.m.

All Cloverbud and Exploring project judging is on Monday in the Kenny Hines Memorial Bldg. and is conference judged for Explorers so the Explorer must be present for judging. It is optional for Cloverbuds.

Removal of Exhibits

REMINDER - FAIR EXHIBITS MAY NOT BE REMOVED BEFORE 4:30 p.m. ON SUNDAY, OR PREMIUMS WILL BE FORFEITED. Also remember you MUST pick up your projects on Sunday between 4:30 and 6:30. Do not leave them at the fair. They will be unsupervised and tossed after the fair.

Presentations Exhibitors - Check-in and Judging

If you are in Presentations (31J Classes E, and F; Speaking & Communications; or Creative Writing) please drop them off at the Seyforth Building (Jr. Fair Office) Monday, August 9th anytime between 8:30 a.m. until 6 p.m. OR 8:30 a.m. - 11 a.m. on Tuesday, August 10th. The judge will be taking time this year to do advance reading. You may come for conference judging anytime between 1-7 p.m. on Tuesday, August 10th in the Kenny Hines Memorial Building.

Barn Permits

For those Junior Fair Exhibitors who have animals and are Grade 6 or older, overnight permits may be obtained from the Fair Office by 8:00 p.m. each evening. The exhibitors may stay only in the barn where their animal is housed. Separate permits are needed for each night, but can be issued all at the same time. The Junior Fair exhibitor's parents or legal guardian must sign regardless of the exhibitor's age. Any unruly conduct such as use of cigarettes, cigars, pipes, illegal drugs, alcohol, abusive language, violent tempers, or intimate physical relations is not allowed. Youth have a midnight curfew. Disciplinary action for failure to comply with the permit procedure, conduct rule or curfew will result in immediate removal from the Fairgrounds, revoking of further overnight privileges and loss of animal premiums.

Dairy & Beef Exhibitor Wash Rack & Manure Bunker Info

We need all Dairy and Beef Exhibitors help in keeping the area between the wash rack, milking parlor, manure bunkers and barns cleaner. So if your critter leaves a "Present" on the way to or from the wash rack or milking parlor, please come back to clean it up. When you put your wheelbarrow into the bunker, please clean up the area around it and put it in as far as it can go. This area has become too littered with "Presents and Bedding" that are not being cleaned up. It will enhance our fair-goers experience to see a cleaner environment. We all need to be conscience of bio-security for ourselves and fairgoers. Thank You.

Feed Drop off Limited Parking

Please be considerate of the Fair's limited parking space when loading or unloading feed near the barns. Do not take more than 20 minutes if possible before moving your vehicle to a designated parking spot. This will help with overall traffic flow and allow everyone to enjoy the Fair. With limited barn space, only bring what you need. However, you

may have to put hay and bedding outside, we recommend bringing a tarp to protect from rain. Please keep our grounds looking neat.

Attention Livestock Exhibitors- Policy for Feeding and Watering

Exhibitors are responsible for feeding and watering their beef/sheep/swine **throughout** the entire fair. All animals are to be fed by 10 a.m. and 6 p.m. daily. The Livestock Committee has adopted a policy known as the 3-strike rule. This rule (condition of animals is periodically checked and strikes will be issued each time improper care of your animal is observed) regarding feeding/watering will be enforced. After the third strike your premium for this project will be forfeited and you will not be able to show this animal species at the Fair next year. All animal areas including Dairy, Goat, Horse, Rabbit, and Poultry as well as Livestock should follow the feeding and watering guidelines. If you have questions about this rule, please contact the superintendent of your species area. Best of luck to all of you at the 2021 Pierce County Fair!

Intrastate Health Certificate for Swine

Remember that all swine must have an Intrastate Health Certificate in order to unload at the fairgrounds. Check with your veterinarian right away to get that taken care of before Fair.

Terminal Swine Show

The 2021 Swine Show will be a terminal show. Swine may not return to the farm after the fair.

Auction Animals Must Be Ready On Friday Afternoon

All 2021 County Fair Auction participants MUST have their animals fit and ready to go by 5:30 p.m. on Friday, August 13th. Buyers will be arriving shortly before that time and the Committee has some new instructions for Auction participants to follow regarding entering and exiting the sales ring. Please be by your animal, ready to talk with buyers no later than 5:30 p.m.

Carcass Show

This year the Carcass Show will be held August 18th at the Spring Valley High School, at 7:30 p.m. Everyone will receive their ribbons and oral reasons will be given by the judge. Anyone having a carcass animal needs to attend that evening in order to receive his or her premium. Bring your thank you note to buyer to the carcass show in order to get your check.

Animal Bedding

Animal Exhibitors are required to bring your own bedding. Due to space constraints bring only what you will be using.

Animal Care at the Fair

- Safe, clean transportation is provided (make sure that all trailers are kept clean and extremely safe.) Biosecurity is everyone's concern.
- Wash your animals at home first. Do not bring dirty animals to the fair.
- Animals are WELL TRAINED and (if applicable) HALTER BROKEN.
- Clean, fresh water is available for all animals.
- Manure/ waste is promptly disposed of. Keep bunker area clean, also around barn and to and from milking parlor
- Each animal is housed with adequate space AND feed is provided for all of the animals!
- Adequate animal washing, preparation and showing techniques are followed throughout the show day. (Make sure blocking and grooming chutes are safe and clean and will not cause injury to the animals.) All grooming shoots must be outside the barns. NO shoots allowed in barns.
- Animal show preparation includes no practices that cause undue stress (absolutely no prodding, kicking, whipping, hitting).
- A veterinarian is on call and makes periodic checks of all animals.
- Adequate ventilation and protection from severe weather is provided for all animals.

Barn Decorations

Barn decorations can be put up on Monday, Tuesday and Wednesday from 2:00 - 9:00 p.m. No decorating in Silver Barn until Tuesday due to show conflict. Decorations can be taken down after 4:30 p.m. on Sunday.

Booth Decorations

4-H <u>CLUB</u> Booth decorations can be put up on Monday, August 9th and Tuesday, August 10th from 8 a.m. to 6:00 p.m. booths are being judged Wednesday. Decorations can be taken down <u>after</u> 4:30 p.m. on Sunday. Nothing is guarded until Wednesday.

Individual booths for Self Determined can be set up Monday until 6 p.m. and Tuesday until 1:00 p.m. judging time.

Sunday Barn Clean-Up

The Fairgrounds staff has requested that all animal exhibitors make a special effort to *CLEAN UP* all stalls, pens and cages before leaving the grounds. All excess manure must be cleaned up or your 4-H club may be charged for cleaning fees.

Prepare for Hot Weather at the Fair

Fans may be a hot commodity during the Fair! If you are working in the Seyforth, Home Ec., Round Barn or the Kenny Hines Memorial Building, you may wish to bring a fan along to help keep you cool.

Conference Judging at a Glance (Exhibitor must be present)

This is a two-way conversation between the member and the judge. The judge will ask questions about your project, what you've learned, what was the most challenging part, etc.? Also, you may ask the judge questions that you may have. The object is for you to learn from your exhibit. Together, you'll discuss your work; don't be afraid of the judge. They are there to help you learn and grow. As you work on your project activities and prepare exhibits for the fair, remember to prepare yourself, too. Conference judging includes an evaluation of both your actual exhibit, and you're learning and knowledge of the exhibit. You should prepare for both parts of the evaluation. Think about what you learned in preparing your exhibit, decisions you made, why you made them, and the quality of your finished exhibit. Knowing and doing the following should help you out:

- 1. Prepare your exhibit carefully and neatly.
- 2. Know why you chose this item as your exhibit and how it fits your project.
- 3. Know how you prepared your exhibit.
- 4. Know how much the exhibit cost in time, materials and effort.
- 5. Be able to explain what decisions you made, and why, in preparing the exhibit.
- 6. Study some background information about the exhibit topic.
- 7. Be able to explain some of the problems you had making this exhibit and what you might do differently if you did it again.
- 8. Decide if the results were worth the costs and what you learned.
- 9. Know what other kinds of exhibits/projects you might be interested in doing in the project area.
- 10. Don't chew gum during the conference.
- 11. Look at the judge.
- 12. Be confident.
- 13. Relax!

Attention Co. Fair Dairy Exhibitors

A few reminders as you get ready for the Fair. Check your animal for warts and ringworm. They won't be allowed to stay on the grounds if they have either. For warts, pull them off with pliers and give a shot of wart vaccine available from your vet. For ringworm see your vet NOW!

Accurate animal numbers are important. If you have an animal that gets sick or injured after the pen numbers have been called in by your leader, please give Bob Traynor a call at 715-977-0499 before August 1st. The more accurate our numbers are when we measure barn space, the better it is for everyone. The Animal ID Form is required this year for each load coming to the Fair page 125 + 127 in the fairbook or on fair website).

It worked well last year to have posted hours when the parlor was open. Expect it again this year. Your cooperation is appreciated. Reminder of early check-in of 3-8 p.m. on Wednesday night; parlor is open Wednesday 5-8 p.m.

Parlor clean-up will be at 11:00 p.m. on Saturday night. If you plan to go to the demo derby, either milk your cows before you go or arrange for someone to milk them for you. All of the parlor clean-up is voluntary. So any help with clean-up is welcome. It enhances our fair-goers experience to see a clean environment.

Since you will be getting milk checks again this year, please be extremely careful to not add treated milk and spoil the load. All necessary precautions must be taken. Please report number of <u>pounds accurately</u>, we are always over by several hundred pounds each year.

Crossover Animals

If same animal is shown in Junior and Open Class Dairy, you must tell the superintendent at check-in and premium will only be awarded in Junior Fair.

Ethics Reminders

Ethics- What is it? - -Knowing what is right from wrong. -Moral philosophy and principles that identify actions as acceptable or unacceptable as generally observed by society.

One way to help us decide is the black and white ethical compass- it has key questions that you should ask yourself when making a decision.

The questions are: Does this practice break Food and Drug Administration (FDA) law?

Does the practice harm the animal? Does it falsely represent the animal? Would you need to lie to the judge to cover it up? Would consumers be upset if they knew about the practice? Does the practice make the animal or by products unmarketable? Does the action represent the person you want to be? Remember that what you do both in the ring and outside of the ring represents both you and the Livestock industry. People notice your actions and judge the whole industry by them!
